I acknowledge that participation in rope suspension, BDSM, and other intimate or physically demanding activities involves **inherent and significant risks, including serious bodily injury or death**. I further acknowledge that not all risks can be identified in advance, and I voluntarily accept full responsibility for risks arising from my participation at this private event and event space.

GUIDING PRINCIPLES

I enter this space under the principles of:

- **RACK (Risk-Aware Consensual Kink):** I acknowledge that I am aware of the risks involved and choose to engage in these activities with informed consent.
- **PRICK (Personal Responsibility Informed Consensual Kink):** I accept full personal responsibility for my choices, actions, boundaries, and participation.

RELEASE OF LIABILITY, WAIVER OF CLAIMS & INDEMNITY

- **Unknown claims:** This release applies to all known and unknown, foreseen and unforeseen claims for injury, damage, or loss.
- **Assumption of risk:** I knowingly and voluntarily assume all risks of injury, disability, death, property damage, or other loss related to my participation.
- **Waiver and release:** To the fullest extent permitted by law, I waive claims against and agree not to sue Craig Just Craig (Artist / Performer), the event producer, venue owners and operators, and their representatives for injuries or damages arising from event activities.
- **Indemnity:** I agree to indemnify and hold harmless Craig Just Craig (Artist / Performer), the event producer, venue owners and operators, and their representatives for injury, death, loss, or damage caused by my actions, including reasonable attorney fees and costs.

PERSONAL RESPONSIBILITY & SAFETY

I understand that I am responsible for educating myself on the risks of any activity I engage in, communicating my limits and consent clearly, monitoring my own physical and emotional state, and withdrawing consent or stopping participation if needed. I acknowledge that I am not relying on the Artist, organizers, or other participants for my safety, and that I am responsible for my own risk assessment, preparation, and aftercare needs. I will respect any monitors or event staff as risk mitigators, not guarantors of safety, and will immediately stop activity if instructed.

CONSENT & RULES OF PARTICIPATION

- Mutual, ongoing consent is required for all activities. Consent may be declined or withdrawn at any time, is specific to each activity, and is invalid under coercion, pressure, or impaired judgment.
- Participant identities, personal information, and activities are confidential and must not be disclosed without express permission.
- Barrier protection is required for sexual or high-risk sexual contact; I am responsible for my own sexual health practices, protection, and disclosures.

- I am responsible for cleanup and restoring any area used during my activity.
- All activities must be conducted safely and in compliance with event monitors and staff direction.
- No unauthorized alcohol or illegal drug use is permitted, and smoking is limited to designated areas.
- No photography, video, or audio recording is allowed without express permission from all participants involved.
- No solicitation or exchange of sexual or other services for money, property, or other valuable consideration is permitted.
- Violation of event rules may result in immediate removal and/or prohibition from future events.

ARBITRATION & ENFORCEMENT

Any dispute arising from participation in this event or this agreement will be resolved by binding arbitration in Fulton County, Georgia, under Georgia law. The prevailing party may recover reasonable costs and attorney fees. If any provision is found unenforceable, the remaining provisions remain in full force and effect.

I affirm that I am at least 18 years of age, legally competent to sign this agreement, have read and understood it in full, understand that I am waiving legal rights, and sign voluntarily.
