Image licensing, conduct, and confidentiality for collaborating photographers

GRANT OF RIGHTS & IMAGE LICENSING

I, the Photographer, grant to **Craig Just Craig** (the "Artist") and the Artist's affiliates and agents a non-exclusive, perpetual, royalty-free license to use, reproduce, edit, and display the photographs and video I create at the shoot or event identified above, across publications, advertising, and media activities, including online use, for promotional, educational, and awareness purposes.

- I retain authorship of my work and the right to use it in my own portfolio, subject to the confidentiality and consent terms below.
- I will provide the agreed deliverables (edited images and/or footage) in the agreed format and timeframe.
- Credit will be given as "photo by [Photographer]" where practical; absence of credit does not invalidate the Artist's license.
- I confirm the work is my original creation and that I have authority to grant this license.

SUBJECT CONSENT & IMAGE USE

I understand that models and participants retain control over their own image and likeness. I agree that I will not publish, sell, distribute, or share any image or recording of a model or participant without that person's express permission and a valid model release, and without the Artist's permission for closed-set material.

CONDUCT, CONFIDENTIALITY & RULES OF ENGAGEMENT

I understand that collaboration with the Artist requires mutual consent, professional communication, and respect for boundaries before, during, and after any shoot or session.

- All access, positioning, direction, touch, and scene elements must be agreed in advance and may be declined or stopped by any participant at any time.
- I will honor closed-set privacy and confidentiality, and any limits on guests, recording, equipment, behind-the-scenes capture, or sharing.
- I will treat participant identities and personal information as strictly confidential and will not disclose them without express permission.
- I will disclose any concern that may affect safety, comfort, scheduling, or my ability to perform the work as discussed.
- I understand this agreement does not guarantee compensation, publication, or future bookings unless agreed separately in writing.
