ASSUMPTION OF RISK & INFORMED CONSENT AGREEMENT

Activity Release of Liability, Waiver of Claims, Express Assumption of Risk & Indemnity Agreement. I affirm that I am fully aware of and understand the inherent hazards and risks associated with BDSM, sadomasochism, sexual activity, and other intimate or physically demanding interactions. These activities may involve physical, emotional, and psychological risk, including but not limited to bodily injury, trauma, or death. I acknowledge that no activity is risk-free, and that not all risks can be predicted, mitigated, or eliminated. I enter this space under the principles of:

- **RACK (Risk-Aware Consensual Kink):** I am aware of the risks involved and choose to engage in these activities with informed consent.
- **PRICK (Personal Responsibility Informed Consensual Kink):** I accept full personal responsibility for my choices, actions, boundaries, and participation.

Assumption of Risk & Personal Responsibility

I am responsible for educating myself on the risks of any activity I engage in, communicating my limits and consent clearly, monitoring my own physical and emotional state, and withdrawing consent or stopping participation if needed. I am not relying on Craig or any organizer for my safety; I am responsible for my own risk assessment, preparation, and aftercare needs, and will only engage within my knowledge, skill level, and negotiated agreements.

Consent & Participation

All activities must be based on explicit, informed, and enthusiastic consent with clear negotiation of risks, boundaries, and expectations beforehand, and ongoing communication throughout. Consent is reversible at any time, specific to each activity, and invalid under coercion, pressure, or impaired judgment. I agree to immediately stop any activity if consent is withdrawn.

Sex & Risk Disclosure

I acknowledge that certain activities carry heightened risk of STI transmission and physical harm. I am responsible for my own sexual health practices, protection, and disclosures, and agree to engage in risk-aware sexual behavior, including the use of protection where appropriate.

Waiver, Release & Indemnity

I fully understand that I am voluntarily participating at my own risk. I waive any claims against the property owners, organizers, or participants, and accept full responsibility for any harm caused by my actions. I agree to indemnify and hold harmless the property owners and organizers from any claims resulting from my participation.
